- The voucher can be used to purchase plane tickets of your choice from the Czech
 Airlines (flight number OK0020–OK2999), including all taxes and charges, but not to pay
 for fees of bonus plane tickets.
- Any difference in the price of the selected plane ticket exceeding the voucher amount must be paid when the voucher is used.
- No service fee is charged for issuing the plane ticket.
- Tickets on which the voucher was applied cannot be refunded.

In the credit card department, Czech Airlines and Citi have been working on a co-brand Czech Airlines Citi Mastercard World credit card, which, thanks to its benefits, belongs among premium products. Holders of these credit cards can enjoy up to two-month-long interest-free period and receive miles to their OK Plus frequent flyer programme for every purchase of products and services made using the card. Using the card actively will also ensure extension of validity of older OK Plus miles for unlimited period of time, the highest tier of travel insurance for the entire family, concierge services and more.
